At MC11, a group of 59 WTO members decided to advance discussions on domestic regulation in parallel to the work of the Working Party on Domestic Regulation. A Joint Initiative on Services Domestic Regulation was issued at the end of the conference. Since then, members of the Joint Initiative have met regularly at the WTO, with a view to concluding negotiations on domestic regulation disciplines before the 12th Ministerial Conference (MC12) in Nur-Sultan in June 2020.
